

I am hereby withdrawing from Hansen Finance Group, a company established in Florida by David Howard with my name as a member, due to the inability to connect with member David Howard. Attempts to form an operating agreement failed after more than a year of association.

Mr. Howard used my public name in conducting business, entering into agreements for the company without my approval, resulting in damage to my name. He also received payment for products I developed via a PayPal account set up in the name of Hansen Finance Group, but failed to deliver all of the products, resulting in further damage to my reputation.

Mr. Howard failed to provide the financial history of the company despite stating on at least 5 occasions that they would be forthcoming and ignored repeated attempts via mail, email, and phone to acquire tax information to file 2009 taxes on the company. Mail sent to the address on record for Mr. Howard is returned as undeliverable.

Mr. Howard may not use my name, Toni Hansen, Trading From Main Street, nor any material I have developed or has been developed in relation to any website I own for his own business interests and retain the option to apply for compensation for any funds acquired by Mr. Howard or any company he is a member of as a result of the use of my name or any website I own.
