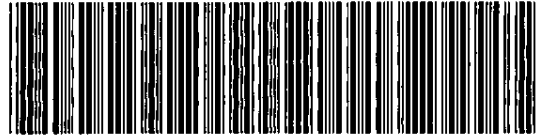

ARTICLE VI - Purpose:


- Organization of events, entertainments, TV and radio programs, ceremonies, concert and theater shows, meetings and seminars. The activity includes scenography, catering, equipments, seating, stages, lights and audio equipments, tents, gazebos, and any other service or product may be necessary for the good result of the event. The company has the faculty to provide own equipment for rent or sub-rent equipment to the final client.
- The company may organize and put on being events finalized to the sale of tickets and receive payments directly by the public.
- The company may also engage activities related to worldwide known personalities, public relations, press office, body-guarding, escrowing, conciergeing and any artist oriented assistance and service.
- Activities related to hotels, camping, resorts, bar and restaurants, catering, dancing, clubs and similar, pools, public events, entertainment activities, theme/amusement parks, management of swimming pools, tennis clubs, multi-sport centers, lidos, (on seashores, lakes and rivers), spa and thermal baths.
- Trading, administration, construction, maintenance, full and partial restoring of buildings or fractions of buildings for any destination, in any country, of it's own property or belonging to third parties; acquisition of contracts and sub-contracts for buildings, plants and real estate works.
- Organization of various kinds of services on behalf of client firms for tourism, recreation, advertising; organization of travels, excursions, parties, services and instruments for any kind of hospitality of tourism and exposition events, tourism for trade and meetings, sport events, religious events, political events, and also events connected to ethnicity and culture on behalf of travel agencies, entrepreneurs, firms, companies and for it's own business.
- Management of services offered by Travel Agencies, also on behalf of third parties.
- Execution under commission of studies, research and advice in the economic, financial, commercial, advertising and marketing segments.
- Commerce, import, export, brokerage and resale of any good (including food and beverage) and service in any legal way: wholesale, end user sales, franchising, rental and leasing.
- The company may act as broker of third parties but only for services not included in the present purpose.
- The company may benefit of own or outsourced staff in order to comply to it's social purpose.

ARTICLE VII - Powers of the Managing Member/s

- Are conferred to the Managing Member the highest ordinary and extraordinary administration powers; with individual signature right; with the authority of carrying out any act he considers adequate for reaching and actuating the purpose of the Company including the possibility of establish and/or close any branch or representative office in any Country, and the consequent appointment of local representatives in each Country.
- The Managing Member can sign on behalf and represent the Company in any legal circumstance: financial transactions, legal issues, bank and financial contracts, credit collection and any other action that requires presence or signature of a company representative.
- Is given the Managing Member the right to open secondary branches of the Company or control, participate other companies, in any Country – if this kind of action is required for the development of the Company - : this power is hereby conferred and any further action conducted is herein ratified.
- The Managing Member is allowed to appoint attorneys and give special powers in writing for any purpose to principals, employees or third parties deciding in each case the limits of the powers conferred and the ways this powers can be exercised.
- If the Managing Member consists in a juridical entity instead of a physical person the powers are assigned directly to it's administrator, director or it's general attorney if provided of extended PoA which includes the control of participated companies.
