ARTICLES OF ORGANIZATION OF WERDA-HECAMIAT FISHING RESORT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be WERDA-HECAMIAT FISHING RESORT, LLC ("company"). ARTICLE II -- ADDRESS The mailing address and street address of the principal of action of the company is 3401 Wilderness Blvd. W. Parrish, F1 34219. ARTICLE III -- DURATION
