AMENDED ARTICLES OF ORGANIZATION OF ON THE COURT HOUSE STEPS, L.L.C.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned certifies that he is acting as the organizing Member for the purpose of forming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit. <u>ARTICLE I</u> NAME AND PRINCIPAL PLACE OF BUSINESS

6. To do everything necessary, proper, advisable or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers set forth in these Articles, either alone or in association with others incidental or pertaining to, or going out of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the State of Florida.
