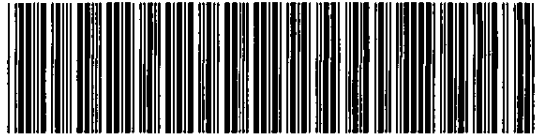

**ARTICLES OF ORGANIZATION  
MEDIVENTURE HOLDINGS, LLC**

ARTICLE I  
NAME

The name of the limited liability company ("Company") is MEDIVENTURE HOLDINGS, LLC.

ARTICLE II  
ADDRESS

The mailing and street address of the Company's principal office is 235 Caddie Court., Debary, Florida 32713.

ARTICLE III  
DURATION

The Company shall have a perpetual existence, unless dissolved upon the written consent of its members or on the occurrence of the death, bankruptcy, resignation, or expulsion of the last one of its members. If, however, within the following 90 days, the personal or other legal representative of the last remaining member agrees in writing to continue the Company and agree to the admission of it or nominee as a member, effective as of the occurrence of the event that terminated the continued membership of the last remaining member.

ARTICLE IV  
REGISTERED AGENT AND OFFICE

ARTICLE V  
MANAGEMENT

The Company is to be managed by its members pursuant to the terms of its Operating Agreement as may be amended from time to time.

ARTICLE VI  
ADMISSION OF NEW MEMBERS

Members of the Company have the right to admit new members. As provided pursuant to the terms of its Operating Agreement as may be amended from time to time, additional members may be admitted only upon the consent of the existing members and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.


ARTICLE VII

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company.

ARTICLE VIII  
ADDITIONAL PROVISIONS

The power to adopt, alter, amend or repeal the Articles of Organization of the Company is vested in the membership.

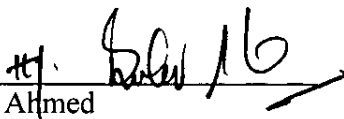

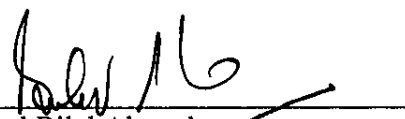
