## ARTICLES OF DISSOLUTION CAMELOT AT DALTON, LLC THEM # 4

As a result of a lawsuit against the developer of Dalton Place at Seagrove (for failure to complete the dovelopment and failure to turn the property over to the Dalton Place at Seagrove HOA), Bayllye G. May obtained title to the common areas in a final judgment December 8, 2008. The subject property was subsequently quit claimed to Camelot at Dalton, LLC on March 2, 2009. Camelot at Dalton was set up as a non-profit corporation (LLC) under IR Code Section 501(e)(4), a social welfare organizetion to manage the Dalton Place at Seagrove Common areas.

The Dalton Place at Seagrove HOA sued Camelot at Dalton LLC and Bayllye G. May for possession of the common areas held by Camelot at Dalton, LLC. Camelot counter sued and, as a result, mediation of the lawsuits took place and a Settlement Agreement dated November 3, 2011 and subsequent Warranty Deed recorded February 17, 2012 at the Walton County, FL Court house, returned the subject common areas to the Dalton Place at Seagrove, HOA. Camelot at Dalton, LLC has no property ownership and no reason to exist since February 17, 2012. All law suits have been dismissed.
