**Articles of Organization
of
NF Mineral Properties, LLC**

(A Florida Limited Liability Company)

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes (the "Act").

1. **NAME.** The name of this limited liability company (the "Company") is **NF Mineral Properties, LLC.**

2. **EFFECTIVE DATE AND DURATION.** The existence of the Company shall commence on March 2, 2009. The period of duration of the Company shall be perpetual.
