**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
NUROCK TOWN PARK, LLC**

The undersigned, as Manager of NuRock Town Park, LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to the terms of Chapter 608, Florida Statutes, the Florida Limited Liability Company Act (the "Act"), states as follows:
