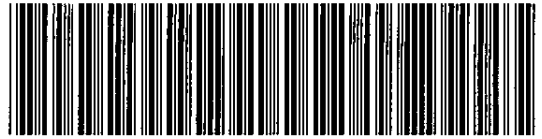




ARTICLE V- DURATION
