ARTICLES OF ORGANIZATION

The undersigned, being authorized to execute and file these Articles on behalf of the members for the purpose of forming a limited liability company under the Florida Limited 20 Liability Company Act, F.S. Chapter 608, and F.S. Chapter 621, does hereby certify and adopt these Articles of Organization.
