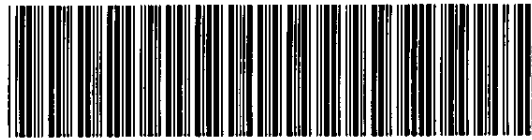

Name

Admission of Additional Members




