ARTICLE VI

No contract or other transaction between the Company and any other Company, and no act of the Company shall be affected in any way or invalidated by the fact that any of the member or manager of the Company are pecuniarily or otherwise interested in, or are Directors or officers, members or managers of, such other Company. ARTICLE IX

Such offer shall be in writing, signed by the Member; shall be sent by registered or certified mail to the Company at its principal place of business, and shall remain open for acceptance by the Company for a period of thirty (30) days from the date of mailing. If the Company fails or refuses within such period to make satisfactory arrangements for the purchase of such shares, the Member shall have the right to dispose of his or her shares as he or she may see fit.

Bach share certificate issued by the Company shall have printed or stamped thereon the following legend: "THESE SHARES ARE HELD SUBJECT TO CERTAIN TRANSFER RESTRICTIONS IMPOSED BY THE ARTICLES OF ORGANIZATION OF THE COMPANY. A COPY OF SUCH ARTICLES IS ON FILE AT THE PRINCIPAL OFFICE OF THE COMPANY."

ARTICLE X

The Managing Member shall have the sole and exclusive right without vote of the members, to sell, lease, pledge, mortgage, transfer, exchange, convert, or otherwise dispuse of, or grant options with respect to, any real property at any time, in such manner, at such times, for such purposes, for such prices, on such terms, and subject to such conditions as the Managing Member may deem advisable.
