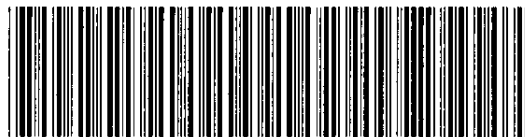

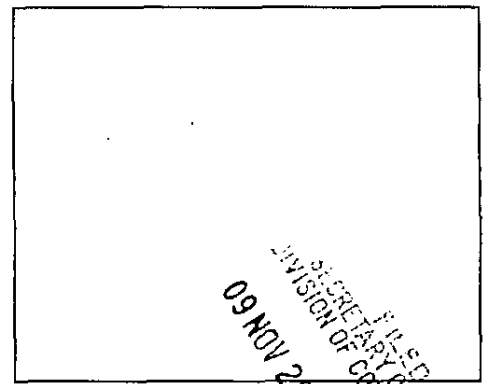

Pursuant to the provisions of Section 608.411 of the Florida Limited Liability Company Act, FIRST COAST EMERGENCY NEUROLOGY, PLLC, a Florida professional limited liability company (the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

ARTICLE I

NAME

The name of the Company is: FIRST COAST EMERGENCY NEUROLOGY, PLLC

ARTICLE II

DATE OF FILING

The Articles of Organization of the Company were filed on March 6, 2009.

ARTICLE III

AMENDMENT

The text of the amendment to the Company's Articles of Organization is as follows:

A. Article I of the Company's Articles of Organization is hereby deleted in its entirety and replaced with the following:

"The name of the Limited Liability Company is: REMOTE MD, PLLC (the "Company")

B. Article II of the Company's Articles of Organization is hereby deleted in its entirety and replaced with the following:

"The street address and the mailing address of the Company is: 836 Prudential Drive, Suite 1601, Jacksonville, FL 32207."

C. Article III of the Company's Articles of Organization is hereby deleted in its entirety and replaced with the following:

"The Company is organized for the purpose of rendering professional services in the practice of medicine and the transaction of any and all lawful business related or incidental thereto."

D. Article IV of the Company's Articles of Organization is hereby deleted in its entirety and replaced with the following:

"The name and street address of the registered agent of the Company is: NRAI Services, Inc., 2731 Executive Park Drive, Suite 4, Weston, FL 33331."

E. Article V of the Company's Articles of Organization is hereby deleted in its entirety and replaced with the following:

"The Company shall be manager-managed. The names and addresses of the managers are:

F. An Article VI shall be added to the Company's Articles of Organization as follows:

ARTICLE VI

INDEMNIFICATION

To the fullest extent permitted by law, the Company shall indemnify any person who was or is a party to any proceeding by reason of the fact that he/she/it is or was a manager or a managing member of the Company or is or was serving at the request of the Company as a manager, managing member, officer, employee or agent of another limited liability company, corporation, partnership, joint venture, trust or other enterprise against liability incurred in connection with such proceeding, including the appeal thereof, if he/she/it acted in good faith and in a manner he/she/it reasonably believed to be in, or not opposed to, the best interests of the Company and, with respect to any criminal action or proceeding, had no reasonable cause to believe his/her/its conduct was unlawful. The Company shall reimburse each person for all costs and expenses, including attorneys' fees, reasonably incurred by him/her/it in connection with any such liability in the manner provided for by law or in accordance with the regulations of the Company.

The rights accruing to any person under the foregoing provision shall not exclude any other right to which he/she/it may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or reimburse such person in any proper case even though not specifically provided for herein."

IN WITNESS WHEREOF, these Articles of Amendment to the Company's Articles of Organization have been executed by a manager of the Company as of the 27 day of November, 2009.
