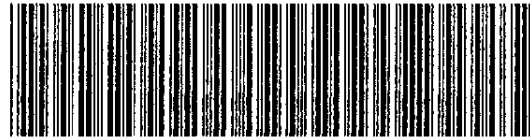



Medical Documentation Systems of America, LLC hereby amends its Articles of Organization and states as follows:


1. The name of the limited liability company is Medical Documentation Systems of America, LLC (document number L09000022055).
