The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I – Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "REVERBERATION MARKETING, LLC".

ARTICLE V – Management:


