The Company is to be managed by its Members.

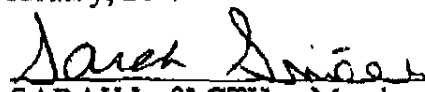
**ARTICLE VII - AMENDMENT OF ARTICLES OF ORGANIZATION**

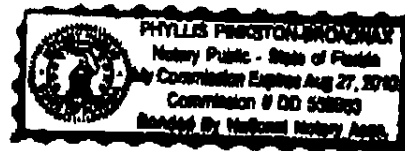
