ARTICLE I

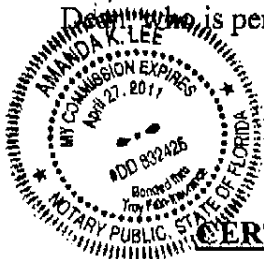
