#### ARTICLES OF ORGANIZATION

#### DELETTRE BUILDING SERVICES, LLC

The undersigned, being a member or duly authorized representative of a member, desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

#### ARTICLE I. Name

The name of the limited liability company is DELETTRE BUILDING SERVICES, LLC (the "Company").

#### ARTICLE II. Address

The mailing address and street address of the principal office of the Company is:

#### ARTICLE III. Commencement of Existence

The name and street address of the Company's registered agent is:

ARTICLE IV. Management and Authority

The Company shall be a manager-managed company.

This Company will be managed by one or more managers appointed by the members in accordance with the terms of the Operating Agreement, if any. The managers may be designated as the president, secretary, and treasurer of the Company, and may also be designated as vice presidents, assistant secretaries, and assistant treasurers, and shall have the authority normally associated with these positions under corporate law. The Company may also designate persons as directors under the Operating Agreement who shall act in a manner similar to the directors of a corporation. The members, at a meeting of the members held not less than annually, shall designate the managers, who may also be members, and the positions that these managers will hold. The initial managers shall serve until the first annual meeting of the members or until their successors are elected and qualify. The initial managers shall be:

Except as expressly provided in the Operating Agreement, if any, the Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.

Pursuant to Section 608.4235, Florida Statutes, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

#### ARTICLE V

The existence of the Company commences on the day of filing.

#### ARTICLE VI

So long as the Company continues to have at least one remaining member, the death, retirement, resignation, expulsion, bankruptcy, or dissolution of any member or the occurrence of any other event that terminates the continued membership of any member shall not cause the Company to be dissolved, and upon the occurrence of any such event, the Company shall be continued without dissolution. At any time there are no members, the Company shall not be dissolved and is not required to be wound up if, within one (1) year after the occurrence of the event that terminated the continued membership of the last remaining member, the personal representative or other legal representative of the last remaining member agrees in writing to continue the Company and agrees to the admission of the personal representative of such member or its nominee or designee to the Company as a member, effective as of the occurrence of the event that terminated the continued membership of the last remaining member.
