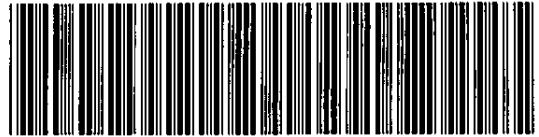

ARTICLE I

Name

The name of the limited liability company is Nole Nook, LLC (hereinafter called the "Company").

ARTICLE II

Duration

The existence of the Company shall be perpetual.

ARTICLE III

Principal Office

ARTICLE IV

Purpose

The purpose for which this Limited Liability Company is organized: Any and all lawful business.

ARTICLE V

INITIAL REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE VI

**Restrictions on Membership and
Right to Continue After Withdrawal of a Member**

transferred except with the consent of the members owning a majority of the interests in the Company. Upon the occurrence of any event that terminates the continued membership of a member in the Company, the remaining members shall have the right to continue the business upon consent of the members owning a majority of the interest in the Company.

ARTICLE VII
Management

The Company is to be managed by managers, who shall serve as managers until the first annual meeting of members or until their successors are elected and qualified. The Company's initial manager is and her address is:


