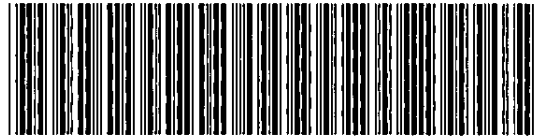

FOURTH: The mailing address and street address of the principal office of the Limited Liability Company is 4125 SE 39th Circle, Ocala, FL 34480.

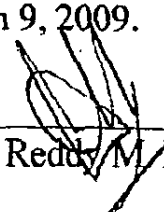

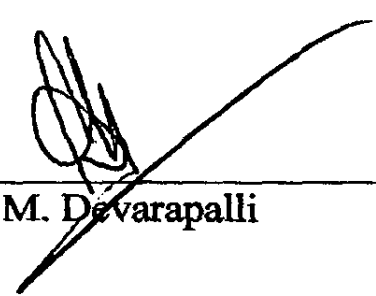
