The Limited Liability Corporation shall have the same powers as an individual to do all things necessary or convenient to carry out its business and affairs, subject to any limitations or restriction imposed by applicable laws of these Articles of organization.

Article Six: The Company shall exist from the date of filing of these Articles of Organization with the Florida Department of State, Division of Corporation until the earlier of Fifty (50) years from the date the filing of these occurrences of any of the events specified in Florida Statutes Section 608. 441 unless continued by unanimous consent of all of the remaining members.

Article Seven: Additional Members and Managers to the Company may be admitted, but only upon unanimous consent of all current members and managers. Each manager listed in Article Four shall have 100% interest from the date of existence until it is alternatively agreed.

Article Eighth: Termination of Membership shall be upon death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event that terminates the continued membership of a member in the Company. The Company shall be dissolved unless the remaining members and managers, by unanimous written agreement, consent to continue the business of the Company.

Article Ninth: The management of the Company shall be a Manager or Managers elected by the Members and Managers as provided in the Operating Agreement. The Company shall be managed in accordance with the Regulations and Operating Agreement adopted by the members and managers. The name and address of the initial manager is:
