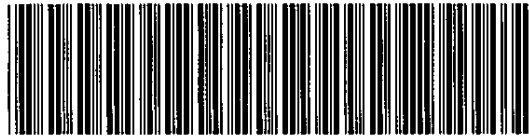

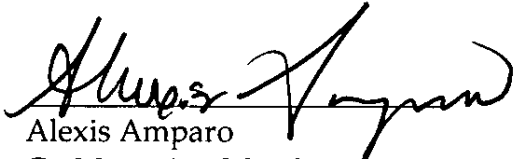
Article VII - Termination of Membership

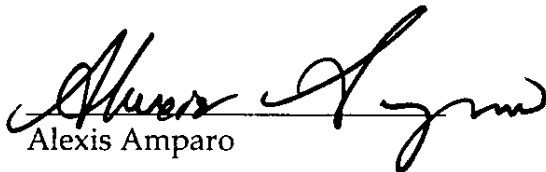
