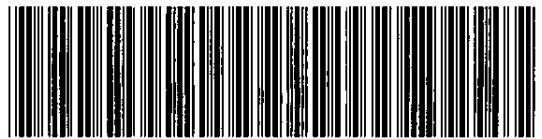

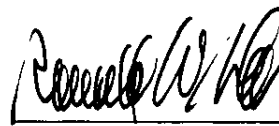
**ARTICLE VI
