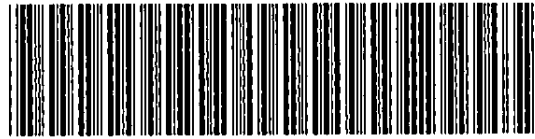



Springfield Station, LLC


This company is formed under the *Florida Limited Liability Company Act*, Chapter 608 of the *Florida Statutes*, by filing these articles of organization with the Department of State.
