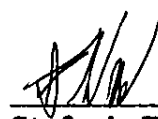

6. **Authority.** These articles are being signed by Stefanie Wallace, the sole member. She will be the managing member.

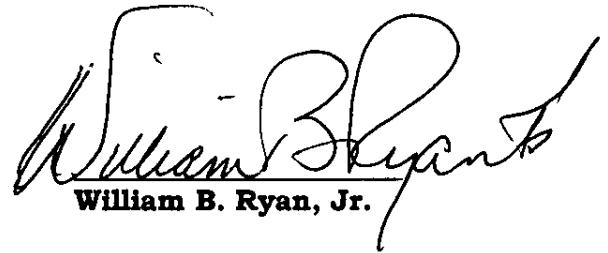
