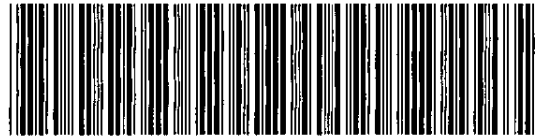

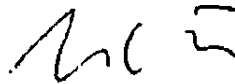

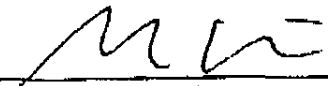
ARTICLE VI - MANAGEMENT
