

The name of the Limited Liability Company shall be TWYBLE ENTERPRISES, LLC.





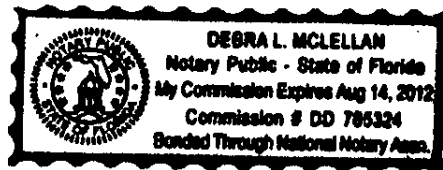
