## ARTICLES OF ORGANIZATION

## OF MAC REAL ESTATE, LLC

# A FLORIDA LIMITED LIABILITY COMPANY

The undersigned hereby presents these Articles of Organization for the formation of a Limited Liability Company pursuant to the Florida Limited Liability Company Act.

# **ARTICLE I**

#### NAME
