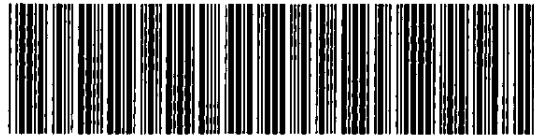

ARTICLES OF ORGANIZATION

KORANG VENTURES, LLC

A Florida Limited Liability Company

In compliance with Chapter 608 F.S., the undersigned, acting as authorized representative, hereby submits the following Articles of Organization for the above named limited liability company.

ARTICLE I – NAME

The name of the limited liability company shall be Korang Ventures, LLC (the "Company").

ARTICLE II – ADDRESS

The Company's principal office address and business mailing address is 1820 W. 46th Street #715, Hialeah, Florida, 33012.

ARTICLE III – REGISTERED AGENT

The initial registered agent of the Company shall be Alex Amoako, who accepts this designation and agrees to comply with the provisions of Chapter 608 F.S. regarding the same. The address of the registered office shall be 1820 W. 46th Street #715, Hialeah, Florida, 33012.

ARTICLE IV – PURPOSE

The purpose for which the Company is formed is to engage in any and all business activity permitted under the laws of the United States and the State of Florida.

ARTICLE V – MANAGEMENT

The Company shall be carried on and managed by at least one (1) manager who shall have the rights and responsibilities prescribed under law and by the company's Operating Agreement. The initial manager of the Company, who shall serve in such capacity until a successor is duly elected or appointed, shall be Alex Amoako.

ARTICLE VI – DURATION


The Company's duration shall commence upon the filing of these Articles with the Division of Corporations and continue in perpetual existence until terminated: (i) in accordance with the Company's Operating Agreement, or (ii) upon written agreement of the majority of ownership interests.
