



Articles of Organization

of

CRIB Holdings II, LLC

A Florida Limited Liability Company

- Name. The name of this limited liability company is CRIB Holdings II, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.
- <u>Duration</u>. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
- 3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.
- Place of Business. The mailing address and street address of the Company's principal office is 2071 SE 28th Street, Cape Coral, Florida 33904.
