## ARTICLES OF ORGANIZATION OF TAMPA BAY PEDIATRIC ENT, LLC

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

#### ARTICLE I Name

The name of the limited liability company shall be: Tampa Bay Pediatric ENT, LLC

#### ARTICLE II Address and Place of Business

The operating agreement shall be repealed or altered only by the members of the limited liability company, in the manner now or hereafter prescribed by the laws of the State of Florida.
