# Articles of Organization of Crab Invest, LLC

(A Florida Limited Liability Company)

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes (the "Act").

- 1. NAME. The name of this limited liability company (the "Company") is Crab Invest, LLC
- 2. **EFFECTIVE DATE AND DURATION**. The existence of the Company shall commence on March 17, 2009. The period of duration of the Company shall be perpetual.
