ARTICLES OF ORGANIZATION

FOR

CLEARWATER TRAVEL RESORT, LLC

The undersigned, authorized representative of the organizing Member of a Limited Liability Company to be formed under the Florida Limited Liability Company Act, as Amended (the "Act"), hereby forms a Florida Limited Liability Company (the "Company") pursuant to the Act, and hereby set forth the following Articles of Organization (the "Articles"):

ARTICLE I

<u>Name</u>

The name of the Company is CLEARWATER TRAVEL RESORT, LLC.

ARTICLE II

Commencement Date and Duration

The Company's existence shall commence on the date these Articles are filed with the Florida Department of State, and shall continue perpetually until dissolved in accordance with Section 608.441 of the Act.

ARTICLE III

<u>Purpose</u>

The Company is created for purposes of engaging in any lawful activity deemed appropriate by the member from time to time.

ARTICLE IV

Principal Office

The mailing address and street address of the principal office of the Company shall be 1206 Manatee Avenue West, Bradenton, Florida 34205 and the mailing address shall be Post Office Box 400, Bradenton, Florida 34206.

ARTICLE V

Registered Agent and Office
