**ARTICLES OF ORGANIZATION
OF

The undersigned authorized agent of the initial Member of the above limited liability company hereby certifies that the Initial Member, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby executes the following Articles to provide for the formation, rights, privileges, and immunities of a limited liability company for profit. The undersigned authorized agent further declares that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE I
NAME**

affairs of the Company not inconsistent with law, this Instrument and the Florida Limited Liability Company Act.


ARTICLE VI

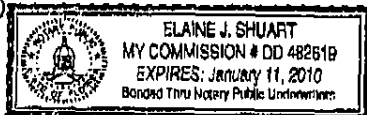


