ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

INNOVATIVE TOOL SOLUTIONS, LLC, (the "*Corporation*"), a limited liability company organized and existing under the laws of the State of Florida, in order to amend its Articles of Organization in accordance with the requirements of Chapter 605, Florida Statutes, does hereby certify as follows:

1. The Articles of Organization of the Corporation were filed with the Secretary of State of the State of Florida on the 20th day of March, 2009, under the name "INNOVATIVE TOOL SOLUTIONS, LLC."
2. The amendment to the existing Articles of Organization being affected hereby is a change in the name of the corporation from " INNOVATIVE TOOL SOLUTIONS, LLC " to "*HAGER-OLSON HOLDINGS, LLC.*"
3. These Articles of Amendment were unanimously approved by joint written action of the Managers and the members of the Corporation the 13th day of March, 2023.
4. After payment of all required taxes and fees, these Articles of Amendment are to be effective immediately upon filing with the Secretary of State of the State of Florida, at which time the existing Article I of the Articles of Organization of the Corporation shall be deleted in its entirety and the following Article I shall be substituted in its place and stead:

"ARTICLE I

Name

The name of this corporation shall be: "*HAGER-OLSON HOLDINGS, LLC.*"
