ARTICLES OF ORGANIZATION OF STONEBROOK ORLANDO APARTMENTS LLC

ARTICLE I Name

The name of this limited liability company is STONEBROOK ORLANDO APARTMENTS LLC.

ARTICLE II Existence

This limited liability company shall have perpetual existence.

ARTICLE III Purpose
