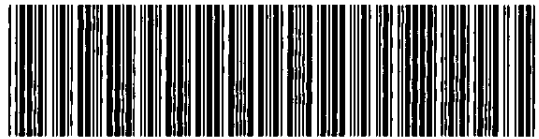

ARTICLES OF ORGANIZATION
OF

The undersigned, a licensed Florida real estate sales associate, for the purpose of forming a professional limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 621, to provide real estate sales services, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

ARTICLE VI -- ADMISSION OF NEW MEMBERS

ARTICLE VII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by unanimous vote of all the remaining members.

ARTICLE VIII -- MANAGEMENT


The company shall be managed by its members and is, therefore, a member-managed company.
