

Section 1.01 Introduction and Preliminary Statements

The undersigned Member desires to AMEND and RESTATE the Articles of Organization of **RCM Professional Practice, LLC**, a limited liability company organized under the Laws of the State of Florida and previously filed on **March 20, 2009** and designated **Document # L09000027656**, pursuant to Florida Statutes §605.0202.

The effect of the amendment and restatement is to change the name of the limited liability company and bring it into compliance with the Florida Revised Limited Liability Company Act (the *Act*) and the Professional Service Corporation and Limited Liability Company Act.

Section 1.02 Name




