

ARTICLES OF ORGANIZATION OF NAPLES CREDIT SERVICES, LLC

THE UNDERSIGNED certifies he intends to form a limited liability company under the laws of the State of Florida and hereby declare that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

ARTICLE I NAME

The name of the limited liability company (the "Company") shall be NAPLES CREDIT SERVICES, LLC.

ARTICLE II ADDRESS

Additional members may be admitted only by the affirmative vote or written consent of a majority-in-interest of the members unless otherwise provided in the Company's Operating Agreement. The existing members shall determine the amount and nature of the contribution by new members at the time the new members are admitted.

A member's interest in the Company shall not be transferred unless the transfer is approved by the members in accordance with the Company's Regulations.
