ARTICLES OF ORGANIZATION OF MDCV MANAGEMENT, LLC

The undersigned, desiring to form a limited liability company under and by virtue of the laws of the State of Florida and specifically pursuant to the provisions of Chapter 608,

Florida Statutes (2008), does hereby execute these Articles of Organization.

ARTICLE I
NAME AND PRINCIPAL OFFICE

The name of the Company shall be MDCV MANAGEMENT, LLC and its principal office and mailing address shall be 1151 North Orange Avenue, Winter Park, Florida.

ARTICLE II REGISTERED AGENT

The name and street address of the initial registered agent and registered office of this Company shall be **PHILIP TATICH**,1151 North Orange Avenue, Winter Park, Florida 32789.

ARTICLE III COMMENCEMENT DATE AND TERM OF EXISTENCE

This Company shall have perpetual existence which shall commence upon the subscription and acknowledgment of these Articles of Organization.
