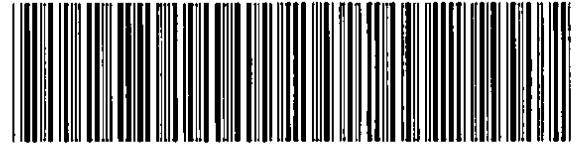

3. Article I of the Articles of Organization is hereby amended and restated to read as follows:


**"ARTICLE I**
