# ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION

OF

### LAKE NONA INVESTMENT HOLDINGS, LLC

The undersigned, as the Member of Lake Nons Investment Holdings, LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to Section 608.411 of the Florida Limited Liability Company Act (the "Act"), states as follows:

- 2. The date of filing of the original Articles of Organization of the Company was March 23, 2009, with document number L09000028407.
- 3. The Articles of Organization of the Company are amended by adding Article X as follows:

This Article X shall not be amended without the written consent of Lake Nona Land Company, LLC."
