ARTICLES OF ORGANIZATION
OF
GT SOUTHERN STAR, LLC

The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLE I
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is JG SOUTHERN STAR SOUTHERN STAR, LLC.

ARTICLE II
ADDRESS

The Company's street address of its principal place of business in Florida is 2207 Inverness Drive, Pensacola, Florida 32503, and its mailing address is 2207 Inverness Drive, Pensacola, Florida 32503, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the Member or Members.

ARTICLE III
MANAGEMENT

The Operating Agreement adopted by the Member or Members may be repealed or altered, a new Operating Agreement may be adopted by the Member or Members, and the Member or Members may prescribe in any Operating Agreement made by them that such Operating Agreement may not be altered, amended or repealed by the manager.

ARTICLE V
AMENDMENT TO ARTICLES

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Section 608 of the Florida Statutes, as shall be prescribed by the




