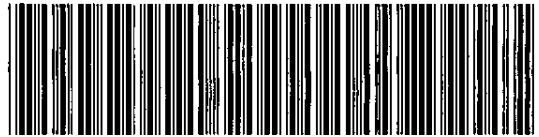





BY THESE ARTICLES the undersigned members form a limited liability company under Florida law:


1. NAME. The name of this limited liability company is HAUTAMAKI & HORIUCHI LLC.
