**ARTICLES OF ORGANIZATION

#### **ARTICLE V**

##### **MANAGEMENT**

The Manager(s) shall also have the rights and responsibilities described in the Operating Agreement of the Company, if applicable. The Manager(s) shall serve in such capacity until their successor(s) are duly elected and qualified.


