## ARTICLES OF ORGANIZATION OF FAIR WINDS CAPITAL, LLC

Pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State, the following are the Articles of Organization for Fair Winds Capital, LLC (the "Company"):

- 1. Name. The name of the Company is Fair Winds Capital, LLC.
