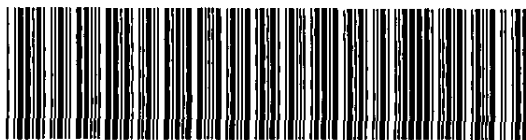

**ARTICLES OF ORGANIZATION  
FOR  
CHARISA, LLC  
A FLORIDA LIMITED LIABILITY COMPANY**

THE UNDERSIGNED, ROBERT M. ARLEN, being the authorized representative of the sole member of Charisa, LLC for the purposes of forming a Florida Limited Liability Company under Chapter 608 Florida Statutes does hereby execute these Articles of Organization and states:

1. **Name:** The name of the Limited Liability Company is CHARISA, LLC.
2. **Principal Office Address and Mailing Address:** The principal office address and mailing address of the Limited Liability Company is 5832 NE 13<sup>th</sup> Way, Pompano Beach, Florida 33064.
3. **Registered Office and Agent:** The registered office of the Limited Liability Company is 110 E. Atlantic Avenue, Suite 330, Delray Beach, Florida 33444. The registered agent of the LLC at this address is Robert M. Arlen. The signature and acceptance of the registered agent is below.
4. **Management:** This shall be a member managed LLC. The managing member of the LLC is CHARLES J. MARCHITELLO, JR., 5832 NE 13<sup>th</sup> Way, Pompano Beach, Florida 33064.
5. **Sub-Chapter S Qualification:** It is intended that this LLC qualifies for the Sub-Chapter S election and that it shall be treated as a qualified entity under Section 1361 of the Internal Revenue Code and its valid regulations (hereafter IRC). Specifically, it is intended that this entity constitute an unincorporated organization that is taxed as a corporation for the purposes of the IRC, that it shall have as members only individuals, estates, trusts, or other organizations which are eligible Sub Chapter S owners under Section 1361 IRC, that all members shall be citizens or residents of the United States, and that this entity shall have only one class of membership as required by Section 1361 IRC. The MGMR shall have full power and authority to make an entity classification election by filing Form 8832 with the Internal Revenue Service and electing Sub-Chapter S status by filing Form 2553 with the Internal Revenue Service.


