ARTICLE I - Name:

The name of the Limited Liability Company is Singapore, LLC

ARTICLE VI - Members Rights to Continue Business:

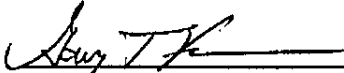

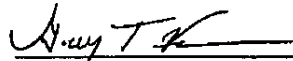
