ARTICLES OF ORGANIZATION OF
WOODBIDGE FUND I, LLC

The undersigned, for the purpose of forming a limited liability company (the "Company") under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, as amended, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company is Woodbridge Fund I, LLC.

ARTICLE II – ADDRESS

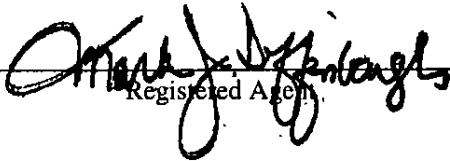
