ARTICLES OF ORGANIZATION

OF

PLAZA GROVE INVESTMENTS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Plaza Grove Investments, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 139 36th Avenue South, Jacksonville Beach, Florida 32250.

ARTICLE II

PURPOSES AND POWERS

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.

MANAGER**

The managers shall be elected in the manner set forth in the Operating Agreement of the Company. Corporate existence shall commence on the date these Articles of Organization are executed, except that if they are not filed by the Department of State of the State of Florida within five (5) business days thereafter, corporate existence shall commence upon filing by the Department of State.
